## General Rules & Conduct

1. **Decorum:** Participants must maintain professional conduct. Any form of heckling, arguing with judges, or disruptive behavior will lead to immediate disqualification. All participants must be on time.

2. **No Electronic Aids:** Use of mobile phones, smartwatches, or any electronic devices is strictly prohibited during the rounds. All such devices must be switched off or submitted to the organizers.

### Round 1: The Statutory Sprint

**Direct Q&A Protocol:** Judges will ask 5 direct questions from each Domain from per team. Teams have 10 seconds to begin their answer after the question is fully read.

**No Conferring (External):** Team members may consult each other quietly, but no communication with the audience is permitted.

**Scoring:** Each correct answer earns 10 points. There is no negative marking in this round .

### Tie-Breaker: The Neuron Rush

**Rapid-Fire Speed:** In the event of a tie, the Neuron Rush rules apply. The judge will pose questions for 60 seconds. The team with the highest number of correct answers within the time limit wins the tie.

## Round 2: The Verdict Vigil (The Finals)

**The Objective:** The Top 3 teams will be presented with a complex legal scenario. The goal is to identify the correct legal outcome based on existing statutes and provide a concise justification.

**The Response Format:** Each team must provide: The Straight Answer and clearly state the specific violation, the applicable section/article, or the final legal result (e.g., “The contract is void under Section 27 of the Indian Contract Act”).

**The Legal Reasoning:** A maximum of two lines explaining the rationale. Brevity and precision are mandatory.

**No Follow-up Questions** : Once a team delivers their answer, it is final. There will be no cross-examination or follow up questions from the judges. The judges will evaluate the response solely on the initial submission.

**Finality of Decisions:** The judges’ interpretation of the law and their scoring are final. No appeals or protests regarding the “correctness” of a legal answer will be entertained once the winner is announced.

### **AWARDS AND RECOGNITION :**

Each member of the winning team will be conferred a Certificate of Merit. Acknowledging their exceptional performance, a token of appreciation will be presented to the winning team.
